## Boulder Junction Public Library Board of Trustees Minutes of the Regular Board Meeting Thursday, June 11 – 4:00 pm

**Call to Order:** Murphy Blank called the meeting to order at 4 pm. The meeting was held in the library, as well as virtually on the BlueJeans video and teleconference platform to protect our community from Covid-19.

**Roll Call of Members:** Members present were Sue Fehlandt, Sara Fieweger, Ellen Murphy Blank, Maggie Wolf, and Mary Van Grinsven. Library Director, Cherie Sanderson, was also present and kept the minutes of the meeting.

**Recognition of Visitors/Comments**: No visitors were present.

**Agenda Approval**: Motion by Fehlandt to approve the agenda as presented with the Chair's discretion to move the order of items on the agenda. Motion seconded by Van Grinsven. Motion carried.

**Minutes Approval**: Motion by Van Grinsven to approve the May 14, 2020 regular meeting minutes. Motion seconded by Fehlandt. Motion carried.

**Treasurer's Financial Report**: Fehlandt presented the May monthly report and the Year-to-Date financial report. End of May balance for the "5311" Checking Account is \$25,682.13 with \$4652.52 segregated for the Reading Garden. End of May balance in the "Non-Profit 1012" Checking Account is \$15,876.19. Total funds available to the board at the end of May are \$42,127.51. Murphy Blank accepted the report to be placed on file for audit.

**Audit and Approval of Bills and Credit Card Transactions**: Sanderson reviewed the bills to be paid. Bills to be paid by the library board total \$0. Bills to be paid by the Town total \$963.92. Bills already paid by the Town total \$4,676.23. Bills to be paid by the Friends total \$962.41. Motion by Van Grinsven to approve payment of the bills as presented and pay the Chase Card bill upon receipt. Motion seconded by Fehlandt. Motion carried.

<u>Friends of the Library Update:</u> The Friends met on Thursday, May 28. They agreed to give extra funding for the summer reading program prizes and craft supplies. They also decided to start the Used Book Sale on June 9 with limitations to the number of books/tables and volunteers.

Wish List Update: All other items are on hold.

<u>Weeding Update</u>: We have not finished weeding Adult Non-Fiction. We will continue when possible to have volunteers in the library.

<u>Programming Updates:</u> All programming is on hold. We have some virtual programs planned as well as prerecorded programs that we can offer to our patrons for a limited time period. Children's Summer Reading Program starts June 17<sup>th</sup> with pick up of reading logs and take and make crafts.

**Copier Update**: The new copier is working out well. There will be staff training needed when we open again.

**Employee Handbook Update**: The town has approved the Employee Handbook.
