Boulder Junction Public Library Board of Trustees Minutes of the Regular Board Meeting Thursday, March 12, 2020 – 4 pm

Call to Order: Murphy Blank called the meeting to order at 4:06 pm.

Roll Call of Members: Members present were Sue Fehlandt, Sara Fieweger, Ellen Murphy Blank, and Maggie Wolf. Mary Van Grinsven was absent with notice. Library Director, Cherie Sanderson, was also present and kept the minutes of the meeting.

Recognition of Visitors/Comments: Luella Doss, President of the Friends of the Boulder Junction Public Library, was present.

Agenda Approval: Motion by Fieweger to approve the agenda as presented with the Chair's discretion to move the order of items on the agenda. Motion seconded by Wolf. Motion carried.

Minutes Approval: Motion by Fehlandt to approve the February 20, 2020 regular meeting minutes and the March 3, 2020 special meeting minutes. Motion seconded by Wolf. Motion carried.

Treasurer's Financial Report: Fehlandt presented the February monthly report and the Year-to-Date financial report. End of February balance for the "5311" Checking Account is \$29,051.77 with \$4652.52 segregated for the Reading Garden. End of February balance in the "Non-Profit 1012" Checking Account is \$15,876.19. Total funds available to the board at the end of February are \$43,999.76. Murphy Blank accepted the report to be placed on file for audit.

Audit and Approval of Bills and Credit Card Transactions: Sanderson reviewed the bills to be paid. Bills to be paid by the library board total \$454.91. Bills to be paid by the Town total \$528.34. Bills already paid by the Town total \$2,883.99. Bills to be paid by the Friends total \$927.48. Bills already paid by the Friends total \$564.11. Motion by Fieweger to approve payment of the bills as presented. Motion seconded by Fehlandt. Motion carried.

<u>Friends of the Library Update:</u> The Friends met on Monday, March 9 and approved the purchase of a new copier and reading room window blinds. Bonnie Spear will be training with Phil and Frauna to take over as Treasurer sometime between now and June. They are waiting for word from Jeff on Used Book Sale during Memorial Day weekend rummage sales.

Children's Program Update: Our numbers have stayed steady.

Weeding Update: We are still weeding Adult Non-Fiction.

<u>Sip 'n Swipe Program:</u> We had a total of 8 students attend at least 1-2 sessions with 3 students attending all 3. Will repeat the classes April 2, 9 & 16 and possibly again in May and June.

<u>Summer Programming Updates:</u> In an effort to offer more of the type of programming that has proven popular in the past, I will be holding "Around the World in 80 Minutes" travelogue programs on the third Thursday of June, July and August (to replace Third Thursday Theatre). I already have July booked. I have also contacted the Historical Society to partner on a monthly historical program in June, July and August. We have already booked Jim Bokern for Tuesday, August 4 at 7 pm. We will also be continuing Neighbor to Neighbor and Northwoods Book Fest.
