## Boulder Junction Public Library Board of Trustees Minutes of the Regular Board Meeting October 14, 2021 – 4:00 pm

**Call to Order:** Murphy Blank called the meeting to order at 4:06 pm.

**Roll Call of Members:** Members present were Sue Fehlandt, Sara Fieweger and Ellen Murphy Blank. Mary Van Grinsven and Mary Zahn were absent with notice. Library Director, Cherie Sanderson, was also present and kept the minutes of the meeting.

**Recognition of Visitors/Comments**: None.

**Agenda Approval**: Motion by Fehlandt to approve the agenda as presented with the Chair's discretion to move the order of items on the agenda. Motion seconded by Fieweger. Motion carried.

**Minutes Approval**: Motion by Fieweger to approve the September 9, 2021 regular meeting minutes and the September 24, 2021 special meeting minutes. Motion seconded by Fehlandt. Motion carried.

**Treasurer's Financial Report**: Fehlandt presented the September monthly report and the Year-to-Date financial report. End of September balance for the "5311" Checking Account is \$17,492.42 with \$3,581.64 segregated for the Reading Garden. End of September balance in the "Non-Profit 1012" Checking Account is \$16,376.19. Total funds available to the board at the end of September are \$33,762.44. Murphy Blank accepted the reports to be placed on file for audit.

**Audit and Approval of Bills and Credit Card Transactions**: Sanderson reviewed the bills to be paid. Bills to be paid by the library board total \$758.58. Bills to be paid by the Town total \$0. Bills already paid by the Town total \$5,779.69. Bills to be paid by the Friends total \$3,604.71. Motion by Fehlandt to approve payment of the bills as presented. Motion seconded by Fieweger. Motion carried.

**Director's Monthly Report (taken directly from the report handed out at the meeting)**: **Circulation and Usage Statistics:** See attached report.

<u>Friends of the Library Update:</u> The Used Book Sale broke records all summer long. They had a record 6 days of sales in the quadruple digits. They had a record high weekly average of \$831 and a record high monthly average of \$4154. The all-time record high final season figure was \$12,463! The Friends met on September 13. They have decided to hold the Cookie Walk this year and will start earlier at 4 pm as well. Luella needs volunteers to help her plan, help her at the sale and BAKERS! Luella has officially resigned as President and Sally has decided not to run again for VP. So, in November, the Friends need to nominate a President and Vice-President who will be voted in at the January meeting. Sally is acting President until they find a new person.

<u>Children's Programming Updates:</u> We received permission to hold an after school reading program at North Lakeland and Jessica proceeded to get everything set up and ready to start October 11<sup>th</sup>. We were notified a week ago that our program is on hold due to the spike in Covid cases at the school right now. They will re-

evaluate early November. The Halloween Book Walk is installed downtown and will stay up until October 31. After that we plan to do a Holiday Book Walk downtown to start the day of the Christmas Walk (day after Thanksgiving). Harvest Fest held story time in the Reading Garden with Granny Autumn and 50 were in attendance.

<u>Adult Programming Update:</u> Books clubs, Knitting and Mah Jongg continue to meet. Only 3 people showed up for the Elder Benefit Specialist drop-in sessions October 12. I do not have any other programs scheduled at this point and have not been asked to offer any.

<u>NWLS/NWLN Updates:</u> One of our patrons won one of the \$50 prizes for Library Card Sign Up Month! Our network conversion is complete, and we are now testing a free trial of Princh wireless printing software because wireless printing no longer works on our new network. NWLS is spearheading a system led ARPA grant application. The only option that would work for us is a Book Bike.

**2022 Town of Boulder Junction Budget Update:** We are fairly certain the town has accepted our budget request. The Budget Hearing will be held on Thursday, November 11.
